(Priority Deadline: April 1, 2021)

*Rosebud-Treasure County Fair is a free admission fair and we see an estimated 14,000 people in four days. The rental cost of each space is determined by size and electrical need. We attempt to provide a wide variety of options in the limited space we have and select unique vendors with this in mind. **Priority assignments are given to applications received by April 1st, 2021.***

I, the undersigned, hereby make application for FOOD BOOTH space at the 2020 Rosebud-Treasure County Fair, **July 21-24, 2021.**

I agree to pay for the food vendor space within ten (10) days from the date of this application, or I will forfeit the space. I agree to abide by the rules and regulations set forth by the Fair Board and agree to sign the attached hold harmless agreement. The Fair will do its best not to duplicate food items being sold.

All vendors are asked to be in place and ready for business by NOON on Wednesday, July 21, 2021. You may leave Sunday morning July 25, 2021. Any questions about this, please call 346-2144.

There can be **no part** of your trailer **extending beyond the edge of the pavement** to allow for emergency vehicle access if necessary. No vehicles may remain with trailers; they must be parked in designated parking areas on the fairgrounds. **Safeguarding your product/display area is your responsibility.**

A food service license is required by the time of service for 2021. Please provide the Fair with a copy for our file. The health inspector will inspect and check for current licensing. Having your license prior to fair simplifies the process for all concerned. **Hours begin at 10:00 a.m. until 9:00 p.m.** Food vendors have the option to stay open later at their discretion.
